1. This offer of LCCM Enrolment Resources is not binding on LCCM and the offer may be withdrawn or modified at any time and [these Terms and Conditions may be varied at any time at LCCM’s sole discretion.]
2. The LCCM Enrolment Resources are subject to availability and LCCM reserves the right to modify the list of LCCM Enrolment Resources at any time and at its sole discretion.
3. To be eligible to receive the LCCM Enrolment Resources you must:
 - 3.1. be a new student starting June 2024 (lessons start w/c 3 June 2024);
 - 3.2. hold a full unconditional offer which you have accepted; and
 - 3.3. have fully enrolled and be in full compliance with the LCCM Terms & Conditions of Enrolment (<https://www.lccm.org.uk/media/781489/terms-and-conditions-of-enrolment.pdf>) (to be fully enrolled you must have confirmed finance in place: either written confirmation of SFE funding or a signed payment plan with UCA for self-financing students); and
 - 3.4. provide a correspondence address and postcode within the TfL zone area and register with TfL as a student to be eligible for the Oyster Travelcard; a pre-loaded amount of up to £150 will be used to load a one month travelcard for zones 1-3 or a £150 pay as you go balance if zones 4-6;
 - 3.5. demonstrate confirmed attendance over 60% for the first 2 weeks of your study to be eligible for the Chromebook and the Spotify Subscription which will be provided following successful completion of the first 4 weeks of attendance;
 - 3.6. actively participate in the LCCM Virtual Learning Environment (VLE) by submitting all required forms;
 - 3.7. fill in in the enrolment resource waiver and release form below;
 - 3.8. please note that Agent recruited students will only be eligible if your agent has signed up to an enrolment resource partnership with LCCM.
4. You will cease to be eligible for an LCCM Enrolment Resource if:
 - 4.1. your attendance falls below 60% in any semester (your attendance will be monitored at all timetabled classes and any unauthorised absence or lateness will be kept on record. For the purpose of the 60% attendance calculation, unauthorised lateness of more than 10 minutes will count as absence); or
 - 4.2. you withdraw or are withdrawn from the course; or

- 4.3. you interrupt your studies; or
 - 4.4. you lose eligibility for finance with no alternative agreed payment method in place.
5. If you cease to be eligible for an LCCM Enrolment Resource, you agree to return your Chromebook and, in the case of subscriptions, agree that your LCCM Enrolment Resource subscription shall be terminated immediately.

If you receive notification from LCCM that you are no longer eligible for an LCCM Enrolment Resource and you do not return the Chromebook promptly to LCCM, you agree immediately to pay to LCCM the as-new replacement value of the LCCM Enrolment Resource as a debt and to indemnify LCCM for all of its costs and expenses in seeking to recover such sums from you.
